The Company will begin trading today under the new ticker symbol MRDN and new CUSIP 58985L number. This corporate action will take effect at the open of business on April 16, 2015.

I am excited to announce after many months of hard work and patience by my counsel, my auditors, my staff and our shareholders, Meridian Waste Solutions, Inc has been approved by FINRA and our new ticker symbol is MRDN. We are clearly defining our company in the marketplace today. Our company is a solutions company in the waste industry. Our core tenants remain the same, as we are a company focused on building recurring cash flow and positive returns centered on the service of Faith, Family, Friends and Community. We seek to build and buy companies that not only *serve* distinctive purposes, populations and industries, but will ultimately *serve* the shareholders as we move to build significant shareholder value thru return on invested capital."

Further, on January 7, 2015, in an effort to give investors a more concentrated presence in the waste industry the Company sold the capitalized software assets of Here to Serve Technology, LLC to Mobile Science Technologies, Inc., a Georgia corporation (MSTI), a related party, due to being owned by some of the shareholders of the Company. No gain or loss was recognized on this transaction as MRDN received equity equal to book value (\$434,532) of the capitalized software in the transaction. It is management's expectations that the spinoff will benefit investors by strengthening the Company to be streamlined in the waste industry and maintaining the financial growth potential of the investment in MSTI. The technology division was a non-core operation of MRDN.
